### 1 OVERVIEW

The Public-Use Data File User's Manual for the 2017–18 Civil Rights Data Collection (CRDC) provides documentation and guidance for users of the 2017–18 CRDC data. The manual provides information about the purpose of the data collection, the universe of schools and local education agencies (LEAs), differences in the restricted-use and public-use data, data collection procedures, data anomalies and considerations, the data file structure, and data processing.

### 1.1 The Civil Rights Data Collection

Since 1968, the CRDC, formerly the Elementary and Secondary School Survey, has collected data on key education and civil rights issues in our nation's public schools. The data are used by the U.S. Department of Education's Office for Civil Rights (OCR) in its enforcement and monitoring efforts, by other Department of Education offices and federal agencies, and by policymakers and researchers outside the Department of Education. The CRDC collects information about school characteristics and about programs, services, and outcomes for students. Most student data are disaggregated by race/ethnicity, sex, English-learner status, and disability status.

The CRDC data are collected pursuant to the 1979 Department of Education Organization Act and 34 CFR Section 100.6(b) of the Department of Education regulation implementing Title VI of the Civil Rights Act of 1964. The requirements are also incorporated by reference in Department regulations implementing Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and the Age Discrimination Act of 1975.

The CRDC is a biennial survey (i.e., it is conducted every other school year); response to the survey is required by law. The CRDC collected data for the 2017-18 school year from the universe of all LEAs and schools. Data from the 2015-16 collection and prior collections dating back to the year 2000 are available.

### 1.2 Purpose

The CRDC is a longstanding and critical aspect of the overall enforcement and monitoring strategy used by OCR to ensure that recipients of the Department of Education's federal financial assistance do not discriminate on the basis of race, color, national origin, sex, or disability status. OCR relies on the CRDC data it receives from LEAs as it investigates complaints alleging discrimination, determines whether the federal civil rights laws it enforces have been violated, initiates proactive compliance reviews to focus on particularly acute or nationwide civil rights compliance problems, and provides policy guidance and technical assistance to educational institutions, parents, students, and others.

### 1.3 Target Population and Respondents

Since the 2011–12 data collection, CRDC data has been collected from the universe of all LEAs and schools, including long-term secure juvenile justice facilities, charter schools, alternative schools, and schools serving students with disabilities. Though data are collected from schools and LEAs; the LEAs are the primary responding administrative unit.

The initial target population for the 2017-18 data collection included 17,744 LEAs and 99,089 schools. Discovered during data collection, some LEAs merged, closed, or opened. Thus, they were added or removed from the initial target population. These adjustments resulted in a revised

final target population of 17,637 LEAs and 97,632 schools. Puerto Rico was also added to the collection for the 2017-18 collection.

#### 1.4 Restricted-Use vs. Public-Use Data File

The restricted-use data file is the primary analysis and investigative file for the CRDC. This file is the basis for enforcement research, as well as for internal program and policy analysis. These data are minimally edited to preserve the original, certified data as submitted. All data elements collected, as well as external data from ED*Facts*, <sup>1</sup> are included in the restricted-use file. Although the chronic absenteeism data is now collected via ED*Facts*, the data file is included in the DVDs that are made available upon request.

The public-use data file is intended for research and analysis external to OCR. The public-use data file is released to maximize the use of statistical information while protecting individually identifiable information from disclosure. The public-use data file contains all data elements and ED*Facts* data; however, some data elements have been rounded, suppressed, or perturbed to protect the identity of the individuals for whom these data are reported. Additionally, suppression for data quality purposes was introduced for the first time in the 2017-18 CRDC and piloted on four modules in the public-use data file. These modules were offenses (OFFN), harassment and bulling (HIBS), restraint and seclusion (RSTR), and discipline (DISC) – Corporal Punishment.

### 2 NEW FOR 2017–18

This section describes the changes in content between the 2015–16 CRDC and 2017-18 CRDC collections.

### 2.1 Changes in Content

Most of the data elements previously collected in the 2015–16 CRDC continued to be collected in the 2017-18 CRDC.

The following data elements were new and optional for the 2017-18 CRDC:

- Number of computer science classes in grades 9-12
- Number of computer science classes in grades 9-12 taught by teachers with a computer science certification
- Number of students enrolled in computer science classes in grades 9-12 (disaggregated by race, sex, disability-Individuals with Disabilities Education Act [IDEA], English Learner [EL])
- Number of students enrolled in Advanced Placement (AP) computer science in grades 9-12 (disaggregated by race, sex, disability-IDEA, EL)
- Whether the school is connected to the Internet through fiber-optic connection
- Whether the school has Wi-Fi access in every classroom
- Whether the school allows students to take home school-issued devices that can be used to access the Internet for student learning

- Whether the school allows students to bring to school student-owned devices that can be used to access the Internet for student learning
- Number of Wi-Fi enabled devices provided by the school to students for student learning use

The following data elements were eliminated for the 2017-18 CRDC:

- Number of students ages 16-19 who participated in LEA-operated high school equivalency exam preparation program, succeeded on test, and received high school equivalency credential (disaggregated by race, sex, disability-IDEA, EL)
- Number of students enrolled in one or more Advanced Placement (AP) courses who received a qualifying score on one or more AP exams
- Number of students enrolled in one or more Advanced Placement (AP) courses who did not receive a qualifying score on any AP exams
- Number of students absent 15 or more school days (disaggregated by race, sex, disability-IDEA, disability-504 only, EL)

The following data element dropped in the 2015-16 CRDC was re-introduced in the 2017-18 CRDC:

• Count of students - Overall student enrollment (LEA)

### 3 DATA COLLECTION

This section describes the major activities in the 2017-18 CRDC data collection. Data collection began for state educational agencies (SEAs) submitting data on behalf of their LEAs on January 23<sup>rd</sup>, 2019 and LEAs on February 4<sup>th</sup>, 2019. The data collection closed to all data submitters on June 21<sup>st</sup>, 2019.

### 3.1 Partner Support Center

The CRDC Partner Support Center (PSC) provided ongoing support for LEAs completing the CRDC. The PSC responded to telephone calls and e-mails from LEAs that needed technical and substantive assistance with the CRDC. Technical assistance provided by the PSC included assistance logging into the online submission tool, creation of additional accounts, explanation of the different navigation methods in the online submission tool, assistance entering the data manually and via flat file upload, resolution of errors, and help with certifying data. Substantive assistance included help with understanding survey questions, definitions, and other topical content related to the CRDC.

In addition to fielding LEA-initiated contact, the PSC conducted outreach. Frequent e-mails that communicated important dates and provided helpful tips about the collection process were sent to the LEAs by the PSC. Follow-up with uncertified LEAs continued weekly after the data collection opened. The follow-ups offered data submission assistance to the LEAs that had not completed the CRDC. Also, the PSC conducted intensive outreach efforts to unresponsive LEAs. Finally, the PSC conducted outreach after the data collection closed requesting data corrections for a series of common data quality errors.

#### 3.2 Data Submission

Data for the 2017-18 CRDC could be submitted into the online submission tool in two ways: by manually keying the data directly into the tool or by uploading flat files of the data into the tool. LEAs could opt to use either method or a combination of the two methods. All data reported either by online data entry or file upload were stored in the same data repository and were visible in the online data entry screens and all system reports. Fifty-four percent (9,603) of the LEAs that began their data submission used the online data entry tool exclusively; the remaining forty-six percent (8,034) used the flat file submission to submit some or all their data. Several SEAs provided all or partial data for the CRDC on behalf of their LEAs.

The online submission tool contained a resources page, accessible from every screen in the tool, to assist LEAs with their submission. The resources offered guidance such as tip sheets on difficult to report survey items and how to avoid flat file submission mistakes. These resources were also made available outside of the online tool at <a href="https://crdc.grads360.org">https://crdc.grads360.org</a>.

### 3.3 Addressing Errors

The CRDC online submission tool automatically performed validation checks on all data as they were entered or uploaded into the system. The system also flagged data errors or potential errors (warnings). These checks are called "business rules" and were run in real time as data were entered into the system or after the flat file was uploaded (see Appendix E for a list of the 2017-18 CRDC business rules).

LEAs could view the Error and Warning Summary page that displayed any data errors, warnings, and pending validation checks. LEAs could correct errors in the online submission tool by modifying the data. If an error could not be corrected, the LEA was instructed to enter a reason and/or comment that explained why the value submitted was valid or, in the case of missing values, by providing an action plan for reporting the required data in the next collection.

#### 3.4 Certification

The last step in the CRDC data collection process was the certification of the submission by an authorized person. Certification attests that the data are "true and correct" to the best of the certifier's knowledge. Only the LEA superintendent, or another person designated by the LEA superintendent was authorized to certify the LEA's CRDC submission. Figure 1 shows a screen capture of the certification page in the online submission tool.

Before a data submission could be certified, all required data had to have been submitted for both the LEA form and all related school forms (unless exempted by OCR), and no errors could exist that had not been explained using a reason code, action plan, or via force certification. Submissions that did not meet these criteria were unable to certify.

For force certification, LEAs were able to certify by contacting the PSC. This was primarily done to remedy a data quality issue that was corrected after the close of data collection period. OCR instructed LEAs who did not collect Restraint and Seclusion data to report null values instead of reporting all zeros for the entire module.

A total of 17,604 LEAs (99.81 percent) of the universe certified their data.

### 3.4.1 Certification by Action Plan

In cases where an LEA was unable to provide data for the 2017-18 CRDC, the PSC requested an action plan from the LEA to ensure that accurate data will be submitted for the 2019–20 CRDC. There were 39 LEAs that provided an action plan in the system. Once OCR approved the action plan, the submission was considered certified. Please see Appendix C for a complete list of these LEAs.

Note: New York City Public Schools submitted a physical copy of their action plan instead of an electronic version completed in the submission system, consequently the LEA's submission was force certified.

### 4 DATA FILE OVERVIEW

This section describes the type and format of the 2017-18 CRDC public-use data file. Data files include only certified data and are organized by related data elements.

### 4.1 File Types

Certifier Information

The CRDC collects data at two levels—the school level and the LEA level—using two different forms, referred to as the School Form and the LEA Form, respectively. Each form contains survey questions relevant to the reporting level. For the 2017-18 collection, the primary method to access and review forms was through the online submission tool. ### 4.2 Variable Types

#### 4.2.1 Identifiers

There are three main identifiers (IDs) used in the data files: one to identify the LEA, one to identify the school (in school-level files), and a combined LEA/school ID COMBOKEY (in school-level files):

LEAID is the 7-digit district identification code

SCHID is the 5-digit school identification code

COMBOKEY is the 7-digit LEAID + the 5-digit SCHID

The COMBOKEY is a unique identifier. In most cases, the LEAID and SCHID combined (COMBOKEY) match the National Center of Education Statistics (NCES) ID used in EDFacts. However, there are schools where the CRDC and NCES identifiers differ due to differences in definitions and procedures between EDFacts and the CRDC. LEAs that did not have an existing ID were issued an NCES ID if there was one, or a new 7-digit LEAID, which consisted of the 2-digit state FIPS code followed by a 5-digit ID assigned by the PSC. Schools that did not have an existing ID were issued an NCES ID if there was one, or a new ID that consisted of the LEAID and a temporary 5-digit school code assigned by the PSC. In addition, the public-use data file contains contact information. For LEAs, the contact information includes name, street address, city, state and zip code. For schools, the contact information includes name, state and whether the school is a juvenile justice facility (JJ).

### 4.2.2 Reported Data Elements

Reported data elements are variables reported by the LEA, either as a direct data entry or a system-calculated value based on reported data. All system-calculated data elements were visible to the LEA and could be changed.

#### 4.2.3 Calculated Totals

Calculated totals are variables that were computed during data processing (i.e., after data collection) and added to the data files (e.g., Total number of students with English Learners, by sex). Totals calculated during data processing were not visible to the LEA or able to be changed by the LEA. Calculated totals and variable names are shown in Appendix B.

#### 4.3 File Structure

There are 33 topical data files based on reported data: 3 LEA-level files and 30 school-level files. These files correspond to the topical modules in which the 2017-18 CRDC data were reported. In addition, there are 18 ED*Facts* data files. The data file structure for CRDC files are shown in Appendix A, along with the file title, the order in which the files are presented, and the counts of each variable type contained in the file.

### 4.4 EDFacts Supplemental Data

EDFacts is a U.S. Department of Education initiative that centralizes performance data supplied by K–12 State Education Agencies (SEAs) with other data assets, such as financial grant

information, within the Department to enable better analysis and use in policy development, planning, and management (see <a href="www2.ed.gov/edfacts">www2.ed.gov/edfacts</a>). EDFacts data from the 2017-18 school year are included in the CRDC data file to assist with analysis and reporting. See EDFacts File Structure in the documentation folder.

### 5 DATA PROCESSING AND EDITING

This section describes the data processing and editing applied to the 2017-18 CRDC during and after data collection. The restricted-use data file was minimally edited to preserve the original, certified data. The public-use file is based on the restricted-use data file. Suppression for data quality purposes was introduced for the first time in the 2017-18 CRDC and piloted on four modules in the public-use data file- offenses (OFFN), harassment and bulling (HIBS), restraint and seclusion (RSTR), and discipline (DISC) – Corporal Punishment.

During data collection, real-time checks were performed to assist LEAs in reviewing their data accuracy. Post-data collection processing included data cleaning, assignment of reserve codes, calculating totals, merging EDFacts data, and assigning processing flags.

#### 5.1 Real-Time Data Checks

The CRDC online submission tool was designed to provide real-time data checks to assist LEAs in reviewing their data accuracy. These checks were performed by the online submission tool business rules, which were designed to highlight potential errors in an LEA submission. Checks

were performed within individual data elements, data tables, an LEA or School Form, and an entire submission. LEAs reviewed, corrected, or responded to errors prior to certifying their data.

There were 140 core business rules for errors, including range and logic checks, valid values rules, and comparisons to prior reported data or ED*Facts* data. A link to the 2017-18 CRDC business rules guide is listed in Appendix E. These checks were run automatically on entered data and uploaded data. Submission level checks were run when a district attempted to certify or selected the pre-certification check. Post-collection data processing of the 2017-18 CRDC data occurred after the data collection closed on June 21<sup>st</sup>, 2019. The post-collection data processing activities are described below.

#### 5.1.1 Assigning Reserve Codes

Special, or reserve, codes were assigned to all variables in the 2017-18 CRDC, as applicable. Force certifications take place when an LEA is unable to provide an action plan and has unique circumstances that prevent them from certifying. Reserve codes provide information on variables that do not have reported values. In order to accommodate a seamless transition to other software packages, reserve codes are standardized and use negative values that are not an actual count.

Table 2 lists the reserve codes and their definitions.

-5 Action Plan

-6 Force Certified

-8 EDFacts Missing Data

-9 Not Applicable / Skipped

-11 Suppressed Data

#### 5.1.2 Skip Logic Failure

There were instances where the skip logic failed to update for the ARRS module. These schools will have a -3 reserve code listed for the module.

#### 5.1.3 Missing Data

For the CRDC data, missing values are represented with a -5 (action plan) or -6 (force certified). Action plans provide steps on how the LEA will collect the data for the 2019-20 collection. Force certified submissions do not have action plans and their missing values are represented with a -6. A full list of force certified districts is located in Appendix D.

Appended data from EDFacts with missing values also appear in the file. Missing values were assigned reserve codes to indicate whether they were missing for required or non-required data elements or for EDFacts data.

### 5.1.4 Calculating Totals

LEAs provided many totals during data collection and some select totals were auto calculated by the online system. Some totals were computed and added to the data files during post-collection data processing. Examples of computed totals include total overall enrollment by sex; total number of students who passed Algebra I in grade 7 or 8 by sex and total number of single-sex interscholastic athletics teams. Calculated totals and variable names are shown in Appendix B.
